WILTSHIRE CARERS ACTION PLAN

This Action Plan is to be read in conjunction with the Wiltshire Carers Strategy and the Wiltshire Young Carers Joint Commissioning Strategy.

As the action headings, we have used the HM Government report 'Recognised, valued and supported – next steps for the Carers Strategy' which was first published on 25 November 2010. This report follows on from the report 'Carers at the heart of 21st century families and communities: a caring system on your side, a life of your own' which was published by HM Government in 2008 and sets out the strategic vision and outcomes for carers:

Vision:

Carers of all ages will be universally recognised and valued as being fundamental to strong families and stable communities. Support will be tailored to meet individuals' needs, enabling carers to maintain a balance between their caring responsibilities and a life outside caring, while enabling the person they support to be a full and equal citizen.

Outcomes:

- 1. Carers will be respected as expert care partners and will have access to the integrated and personalised services they need to support them in their caring role.
- 2. Carers will be able to have a life of their own alongside their caring role.
- 3. Carers will be supported so that they are not forced into financial hardship by their caring role.
- 4. Carers will be supported to stay mentally and physically well and treated with dignity.
- 5. Children and young people will be protected from inappropriate caring and have the support they need to learn, develop and thrive and to enjoy positive childhoods.
- 6. Carers can be free from discrimination so that they have fair & equal access to services.

Outcome 1 – Carers will be respected as expert care partners and will have access to the integrated personalised services they need to support them in their caring role. This means that carers have the opportunity to have their opinions listened to and have increased choice and influence over the services and support they receive, and that this is built into the ongoing planning, improvement and development of those services.

Outcome 5 – Children and young people will be protected from inappropriate caring and have the support they need to learn, develop and thrive and enjoy positive childhoods.

This outcome is part of the Wiltshire Young Carers Joint Commissioning Strategy Implementation Plan and can be read separately, but alongside this Action Plan.

The outcomes covered in the Implementation Plan are:

- 1. Working towards the prevention of children and young people undertaking inappropriate and unsafe levels of caring, which impacts negatively on their well-being
- 2. Developing a whole family approach to assessments and service delivery.
- 3. Promoting a positive culture where young carers and their families can identify themselves and are recognised as expert partners in their own lives and can become fully involved in development of services.
- 4. Young carers will have the same access to education and career choices as their peers.
- 5. Raising awareness of young carers, their families and their issues.
- 6. Services to young carers will provide good quality, safe support for those young people who continue to be adversely affected by their caring role.

Outcome 6 - Carers can be free from discrimination so that they have fair & equal access to services. This means that carers can use all services & support equally without discrimination and will have the opportunity to contribute their opinions without discrimination or harassment.
